EXAMINATION, 2024

Based on the results of the written examination of the Indian Economic Service / Indian Statistical Service Examination, 2024 held by the UNION PUBLIC SERVICE COMMISSION from 21st to 23rd June, 2024 followed by interviews for Personality Test in December, 2024, the lists, in order of merit, of the candidates who have been recommended for appointment to the posts in Indian Economic Service and Indian Statistical Service are attached as Annexure I & II.
