### Result of the Preliminary Test held on 28.04.2024 (Sunday) under the District Judge (Entry Level), Direct from Bar Exam-2023.

The Preliminary Test was held on 28.04.2024 (Sunday) at two examination centres situated at Patna in which 2311 candidates, out of 3439 candidates to whom admit cards were issued, had appeared.

**Note : 1.** The aforementioned result has been prepared on the basis of provisions as contained in Advertisement no. BSJS/1/2023, The Bihar Superior Judicial Service Rules, 1951, letter number 588 dated 17.01.2017 & 469 dated 11.01.2021 issued by the General Administration Department, Govt. of Bihar to the Patna High Court & other authorities as well as communication made to the Court by the State Government vide memo no. 12033 dated 18.09.2017 & letter no. 127 dated 05.01.2022 regarding roster formula applicable in respect of reserved category candidates.

**2.** The 30 vacancies that includes 4 backlog vacancies [3 for SC of District Judge (Entry Level), Direct from Bar Exam-2020 and 1 for ST of District Judge (Entry Level), Direct from Bar Exam-2021] advertised vide aforesaid advertisement has been distributed among different categories in the following manner-

(i)	UR	- 10 (including 4 for women)
(ii)	SC	- 7 (including 2 for women)
(iii)	ST	- 1
(iv)	EBC	- 6 (including 1 for women)
(v)	BC	- 3 (including 1 for women)
(vi)	EWS	- 3 (including 1 for women)

Out of the aforesaid 10 (including 4 for women) vacancies of UR, 3 vacancies (including 1 for women) shall be reserved for candidates of SC category for the next three selection process including the current one as per the Rule 4A (vi) of The Bihar Superior Judicial Service Rules, 1951 as three vacancies of SC were filled up by UR Candidates in last selection process, i.e., District Judge (Entry Level), Direct from Bar Exam- 2021. **As such, there remains only 7 (including 3 for women) vacancies for UR category and 10 (including 3 for women) for SC category.**

Further, one orthopedically handicapped (OH) candidate shall be appointed as per the availability and counted in the respective category to which the selected OH candidate belongs at the final stage.

**3.** The candidates, approximately ten times the number of vacancy category wise, in order of merit, have been shortlisted for Main (Written) Examination as no minimum qualifying marks has been fixed for qualifying in the said examination.

**4.** Amongst 298 candidates shortlisted for the Main (Written) Examination, there are 71 candidates in UR category; 91 candidates in SC category; 4 candidates in ST category; 61 candidates in EBC category; 31 candidates in BC category and 31 candidates in EWS category.

Further, 9 candidates of OH category are included in the aforesaid result additionally as 1 OH candidate is already included in the UR category, taking into consideration of OH vacancy as stated above. The required number of SC & ST candidates are not available, therefore, the number of the shortlisted candidates in SC & ST category remained less than their requisite proportionate number.
